

## 2013 LWV Essay Contest Winners

For the second year Henry Clay High School students swept the honors in the Lexington LWV Essay Contest. Prizes were awarded in mid-December to 10th grader Kayla Beebout (\$250 for her essay *Beware the Lair of the Gerrymander*), 9th grader Anya Slepyan (\$150 for her essay *Gerrymandering: The Partisan Redistricting Process That Is Undermining Democracy*), and Evan Vee Hays (\$100 for his essay *Gerrymandering: The Bane of Democracy*). As sponsoring teacher of all three students Scott Brown received an honorarium of \$200.

This year students were asked to demonstrate their understanding of the concept of gerrymandering, the implications of its use in politics today, and possible solutions to the problems associated with it. The winners drew on a variety of resources to enhance their understanding and demonstrated their competence as writers in the essays they produced.

The contest committee included Tammy Fagley, Lynne Flynn, Judy Johnson, Barbara Sterrett, and Elaine Sutter.

## National League Revisiting Position on Agriculture

As explained in the January issue of the Kentucky Voter, the LWV plans to revise its position on agriculture which was written in 1988. In order to begin this process local Leagues have been asked to respond to 11 study questions grouped under four topics. The complete set of questions was printed in the Kentucky Voter, which can be found online at <http://lwvky.org>.

It was decided at its January 11 planning meeting that the Lexington League will focus on two of the four topic areas in the agricultural update document—Economic Health of the Agricultural Sector and Food Labeling. An educational presentation in March has been scheduled to develop understanding of agricultural economics. The website <http://www.fooddialogues.com/search/node/food%20labeling> is a source of much information about food labeling issues.

Here are the questions for us to consider. We will eventually decide **YES**, **NO**, or **NO CONSENSUS** on each.

### Economic Health of the Agricultural Sector

1. *Should government financial support for agriculture be directed to:*
  - a. Subsidized agricultural credit (loans)
  - b. Disaster assistance
  - c. Crop insurance
  - d. Farms that supply local and regional markets
  - e. Subsidized implementation of best management practices
  - f. Commodity crop programs, e.g., corn, soybeans, sugar, cotton, wheat
  - g. Commodity livestock program
  - h. Commodity dairy program
  - i. Specialty crops, e.g., fruits, vegetables, nuts, etc. Other production methods, e.g., organic, hydroponic, urban, etc. farms

### Food Labeling

9. *How sufficient are the following regarding current food labeling?*
  - a. Nutrition Facts on food labels
  - b. Nutrition Facts on food labels as a means of consumer education
  - c. Common allergen labeling
  - d. Health and ingredient claims that consumers can understand

## Bills LWV Is Supporting

**HB 70** –**Restoration of felons’ voting rights** - Sponsor is Rep. Crenshaw. Passed House, sent to Senate, assigned to State and Local Governments Committee.

**HB 3** –**Amendment of legislative ethics law** – would require mandatory ethics training and education for legislators to include information on sexual and workplace harassment; eliminate campaign contributions from lobbyists during General Assembly sessions; require development of a job classification, promotion, discipline, and compensation system for LRC employees. Sponsor is Rep. Overly et al. Assigned to State Government Committee.

**HB 28** –**Strengthen code of legislative ethics governing political contributions from employers of lobbyists** –require reporting of advertising spent to support or oppose legislation and limit allowance of food and beverages and cost of attendance for legislators to in-state conferences. Sponsor is Rep. Yonts. Assigned to State Government Committee.

**HB 8** –**An act relating to domestic violence** – Amend KRS 403.720 to include dating partners among class of persons allowed to obtain domestic violence protective orders and amend KRS 403.735 to require the court, when a petition involves a minor, to impose conditions that cause the least disruption to education if the parties attend the same school system. Sponsor is Rep. Tiley. Reported favorably out of Judiciary Committee, had two readings, recommitted to committee.

**HB 72** –**Public financing of judicial campaigns.** Sponsor is Rep. Wayne. Assigned to Judiciary Committee.

**\*\*HB 195** -**An act relating to energy** –require retail electric suppliers to use increasing amounts of renewable energy; require retail electric suppliers to take energy-efficiency measures that increase energy savings over a period of time. Sponsor is Rep. Marzian. Sent to Tourism Development and Energy. *LWV is studying this bill.*

**SB 77** - **Abolition of the death penalty** –Sponsor is Sen. Neal.

**League members will be informed by the Legislative Committee when a bill we support is about to have a hearing. This is when we issue a “call to action.” Please call [1-800-372-7181](tel:1-800-372-7181) to leave a message for your legislator to vote for the bill we support.**

For all members—we hope the Voter provides clear information about events and activities. Please check the calendar in this issue and plan on joining your colleagues for at least one event in 2014.


