VOTING REQUIREMENTS

To register, you must be: 18 or older on or before the November Election, a citizen of the United States and a resident of Kentucky **28 days** before Election Day. If you have lost your civil rights or are a convicted felon, your rights must have been restored to be eligible to vote. (To learn more, search for Restoration of Civil Rights in KY and/or Courts.KY.Gov. and check Record Expungement.)

****You may now register online to vote. Go to www.GoVoteKY.com and complete the application.**

Also you may register at: The County Clerk's and Drivers License offices; Social Service agencies (if you are a client of K-TAP, Food Stamps, Medicaid or WIC offices); Armed Forces Recruitment centers; high schools (if you are student or staff member); and the Health Department Central Registration Office. You may change your address or name at the above places.

To register by mail, call 859-255-8683.

Registration cards must be in the Clerk's office or postmarked 28 days before the election. The last day to change party affiliation prior to the spring Primary Election is **Dec. 31.**
