On Wednesday, February 25, twelve League members from across the state gathered in Frankfort for League Lobby Day. In the morning some of us had appointments to visit with our legislators to discuss bills we are supporting or op-

where bills were discussed and then voted upon. Some of us attended the Domestic Violence Prevention Rally in the Rotunda. Then we ate lunch together in the Capitol Annex cafeteria. Some members stayed to observe the formal Senate and House sessions at the Capitol Building in the afternoon.

This year there seemed to be many more people than usual lobbying for bills they support and there was palpable excitement in the air. Some came from non-partisan organizations similar to ours, while others were paid lobbyists.

## Christian Muslim Dialogue

On Saturday, March 28 at Hunter Presbyterian Church, writer and scholar Charles Upton will discuss Dr. John Morrow's 2014 European trip undertaken to share his work authenticating and studying what has been called Mohammed's Covenant with the Christians of the World.
Dr. Morrow, who holds a PhD. from the University of Toronto, is both Native North American and Muslim. In addition to his academic duties he travels the world working for peace and justice. Because Dr. Morrow is based in Canada, Charles Upton, a Kentucky writer and scholar, will discuss the reception his work is eliciting.
The presentation will begin at 10:00 a.m. It will be followed by a potluck meal at noon.
