Ways to Take Action as a LWV Member

The legislative session is in full operation and there are several bills on which the League has taken positions. Major ones you may already be following in the news are listed below. As an active LWV member you will want to:

- Check out the website http://www.lrc.ky.gov/record/16RS/record.htm to read the full text of each bill.
- Follow the progress of each bill carefully.
- Use the website http://www.lrc.ky.gov/ to find your legislative representatives and contact each through his/her office or send an email using http://www.lrc.ky.gov/ whoswho/email.htm to let them know your position on particular bills.
- CHOOSE ONE (OR MORE) BILL AND LET YOUR LEGISLATORS KNOW WHERE YOU STAND.



SB 1 (M. Wilson et al)—Educational Standards—this bill would change the way state academic standards are reviewed and the way schools and students are assessed. Passed in Senate; pending before the House Education Committee.—**OPPOSE** and suggest it be temporarily withdrawn.

SB 45 (C. McDaniel)—Requires the disclosure, upon request, of the retirement benefit information of current and former members of the General Assembly. Passed in Senate; pending before House State Government Committee.—**SUPPORT**

SB 89 (D. Carroll)—Would end current moratorium on nuclear power plant construction in KY. Passed Senate Natural Resources and Energy Committee. Sent to full Senate for vote.—**OPPOSE**

SB 192 (Jared Carpenter et al)—Would require all public high school students to pass a civics test in order to receive a regular diploma—pending before Senate Education Committee.—**SUPPORT**

HR 6 (J. Wayne) —Support the United Nations Convention on Elimination of All Forms of Discrimination against Women.—pending before House Elections, Const. Amend. Committee.—**SUPPORT**

HB 40 (D. Owens et al)—This bill will allow the courts to seal the felony records of up to 94,000 Kentuckians. Passed in House; pending before the Senate Judiciary Committee.—**SUPPORT**

HB 70 (D. Owens)—constitutional amendment allowing restoration of voting rights for felons who have paid their debt to society— pending before Senate Judiciary Committee.—SUPPORT

HB 147(G. Stumbo)—Would raise campaign contributions limits and amend contribution reporting laws. Passed the House; pending before the Senate State and Local Gov't Committee.—**OPPOSE**

HB 152 (J. Wayne) – Called the "streamsaver bill" would amend surface coal mining laws to protect environment—pending before House Natural Resources Committee.—SUPPORT

HB 316 (Rita Smart et al)—Would clearly define "bullying" for law books –Introduced in House-posted in Education Committee. Passed in House; pending before Senate Education Committee.—**SUPPORT**

HB 339 (M. Marzian)—Would require electric utilities to adopt renewable energy portfolio and energy efficiencies portfolios. Sent to House Tourism Development and Energy Committee. No action since Feb. 8.— **SUPPORT**
