
Linda Gorton, former Council Member and Vice Mayor of Lexington

The Lexington LWV held its annual meeting on Saturday, April 18, at Faith Lutheran Church. It was a treat to see League members who have not been able to participate in some time. All enjoyed a catered breakfast as the yearly business was discussed and voted on. The officers and board for 2016 are: Tammy Fagley, president; Donna Blue, second vice president; Lynne Flynn, secretary; and board members Richard Heine, Judy Johnson, Erin Kidder, Carol O'Reilly, and Barbara Sterrett. First vice president Cindy Heine and treasurer Steve Senft have another year of a two year term to serve and, therefore, were not on the slate presented for a vote.

The budget and the proposed program for the coming year were accepted. The first event of the year will be a wine/cheese membership party. Remember Talon Winery last fall? Look for details in the Summer issue of the VOTER which will be published in mid-July, covering both the months June and July. Members also received a copy of all committee reports for the 2014-15 year.

Once business was completed, Linda Gorton joined the group to share her reflections on the Lexington she helped shape over her 16 years in public service. She talked about her experiences working with four very different mayors and more than 30 council members. Her prepared talk became a conversation about the positive changes in the city over the last two decades and some of the exciting challenges ahead for the city. Although it proved unsuccessful, she was proud of the strong citizen led effort to buy the water company. Goals achieved included the protection council was able to put in place for our beautiful farmlands, the passage of a fairness law way ahead of its time, and the first move toward actually achieving affordable housing funding as well as the establishment of an office of Homelessness Prevention/Intervention. Conversation turned to the future and the possibilities for a more practical refurbishing of Rupp Arena, the extension of the bike trail, and the proposed open waterway through downtown which would open up a multi-use green space.

League members ended a very busy spring season better informed about our community and with ideas for possible future study and action. Our thanks to Linda Gorton for inspiring us.



The Lexington LWV book club will meet **Tuesday, May 19 at 1:30 p.m.** at Terry Naydan's house. The address is 3013 Charleston Blvd.

The book to be discussed is Marcia Coyle's *The Roberts Court*. Coyle is the chief Washington correspondent for the National Law Review. Jeffrey Rosen, president of the National Constitution Center in his Washington Post review, commended Coyle for avoiding politically polarized oversimplifications in prior examinations of the court. He writes, "The great strength of Coyle's book is the depth and balance of her reporting."

Terry will be leading the conversation about the four landmark decisions of the Roberts Court—*Parents Involved, District of Columbia v. Heller, Citizens United,* and the health care decision. Protecting Voting Rights

April saw positive results in League battles to protect voting rights.

Georgia—The LWV and coalition partners were successful in defeating proposed legislation that would have cut early voting from 21 days to 12.

Virginia—Gov. Terry McAuliffe vetoed a bill that would have required absentee voters to provide a copy of their photo ID with their ballot. This requirement would potentially disenfranchise thousands of registered voters who do not have a valid voter photo ID due to disability, age, illness, transportation or financial issues. The League was active in opposing this legislation and urged the governor not to sign the bill.

Ohio—Gov. John Kasich used his line item veto authority to kill language that would have required out-of-state college students who register to vote in Ohio to quickly obtain in-state drivers' licenses and/or vehicle registrations in order to vote. The governor acted at the urging of the LWV and other voting rights coalition members.

For over 95 years the League has fought for free, fair and accessible elections. The national League reports, "While the assault on voting rights has increased over the past, the League has risen to the challenge in dozens of states across the country. We are confident that the rights of voters will prevail, in large part, because the League has been and always will be there to fight for the right to vote for all eligible voters."
