

# Lexington League Presents Discussion of College Costs on Nov. 4



The League of Women Voters of Lexington will meet to explore college and postsecondary education access and affordability barriers for Kentuckians on Saturday, November 4, 2017 from 10:00 a.m. until noon at the Bluegrass Community and Technical College Newtown Campus, Classroom 107. This meeting is open to the public and all are invited to attend.

Members of the Student Voice team of the Prichard Committee will present their research findings on the topic. This group of students has studied data, interviewed students across the state and assembled a wealth of information to share. Recently the group released a new book, Ready or Not: Stories from Students Behind the Statistics.

The Student Voice team will be joined by Perry Papka, a policy analyst at the Prichard Committee with a focus on postsecondary education, and Erin Klarer, Vice President for Government Relations at the Kentucky Higher Education Assistance Authority.

For those not familiar with the Newtown Campus of BCTC, it is located at 500 Newtown Pike in downtown Lexington. The classroom building is the new building with blue-green windows that sits closest to Newtown Pike. Enter the glass doors and classroom 107 will be down the corridor on the left. The escalating cost of college education is of great concern. This discussion will be an excellent opportunity to hear details from students and experts in the field. # **LWV Members Consider Money in Politics**

Lexington League members traveled to Frankfort on Thursday, October 19 to participate in a program entitled "Money in Politics: Our Republic in Crisis." The event was sponsored by Together Frankfort and the New Kentucky Project. Together Frankfort is a nonpartisan volunteer group of Kentuckians who seek to exercise and protect the principles embodied in the Constitution by being engaged and responsible participants in democracy. The New Kentucky Project seeks to move the state forward and modernize it through a variety of policy initiatives based on discourse across party lines. The LWV of Kentucky supported this event and several Louisville members also attended the session.

Some of the issues discussed include unlimited expenditures to PACS, lack of disclosure of those expenditures leading to "dark money," public financing of campaigns and the power and lack of regulation of social media. Panelists included Adam Edelen, former state auditor and co-founder of the New Kentucky Project; Krystal Ball, founder of the People's House Project; Dr. Donald A. Gross, UK professor emeritus of political science; and Martin Cothran, senior policy analyst for the Family Foundation of Kentucky.

# **LWV Voter Registration Activity**





#### Texas League of Women Voters Successfully Protects Voter Data

In October the League of Women Voters of Texas, the Texas State Conference of the NAACP, and an individual plaintiff won a temporary restraining order preventing the Texas Secretary of State from disclosing voter data to the Presidential Advisory Commission on Election Integrity. The plaintiffs are represented by the Brennan Center for Justice at NYU School of Law and Kirkland and Ellis, LLP.

The commission was created by executive order in May of 2017 because of the president's repeated assertions that millions voted illegally in the 2016 election. The Brennan Center website carries the explanation that "for years, claims of fraud have been used to justify unwarranted voting restrictions. There is strong reason to suspect this Commission is not a legitimate attempt to study elections, but rather a tool for enabling voter suppression."

#### **Does One Vote Make a Difference?**

A new study of the November, 2015 elections completed by the nonpartisan voting rights group Democracy North Carolina shows a surprising number of cases where a handful of votes made a difference.

Researchers identified 69 cities where the mayor or a council member won by five or fewer votes. In 31 cities, many of them small towns, how one person decided to vote made the difference between win or loss. In four communities a coin toss broke ties for council seats and in one town the winning council candidate's name was drawn from a box.

Remember these results the next time you wonder if your one vote <u>really</u> makes a difference.
