THE NUNS ON THE BUS COME TO TOWN!

Thursday, October 2, the Lexington LWV joined several other local nonpartisan groups in welcoming the Nuns on the Bus campaign to mobilize "We the People, We the Voters!" The rally was held on the plaza in front of the judicial buildings on Limestone between Main and Short Streets.

Sister Simone Campbell, the social justice spokesperson who originated this method of reaching communities across the country, spoke clearly about the need to vote, to encourage others to vote, and to hold candidates responsible. As she said, "When the people vote, politicians listen."

Sister Simone was joined by several eloquent speakers, including some local candidates and social justice advocates, all speaking to the importance of exercising our right to vote.

Know Your Candidates... Check out the Forums

This fall the Lexington League has made a strong effort to present as many candidates for office as possible in forums that can be accessed easily on demand. The final number totaled **19** forums held through the months of September and October featuring candidates for state and local offices.

The work to present these forums began in June working with the library to set a tentative schedule. There was much to do through the summer. Finally, each session needed moderators, time keepers, volunteers to collect and review questions. In all, it was a very big job!

Cindy Heine was the guiding force who held the whole process together and made everything come together seamlessly. More Information for Voters

An interesting tool for voters seeking information about candidate positions on issues is Project Vote Smart's website **votesmart.org**. Typing in a candidate's name will bring up a number of choices—Bio, Votes, Positions, Speeches, Funding. Obviously, there will be more information on incumbents than challengers. This project is the work of a nonpartisan grassroots organization that is gaining national respect.

On the local level, the ballot is lengthy this fall, running to two full pages. It is wise to go to the Fayette County Clerk website <u>fayette-countyclerk.com</u> and select the tab <u>Elections</u>. From the drop down window choose <u>My Registration Information/Sample Ballot</u>. Enter your Social Security Number and birth date and a sample ballot will appear. Print this off ahead of time, study it, mark your choices. On Election Day take it with you to the polls.

Ordinarily voting takes less than two minutes but this year allow extended time. One last hint—the machines usually record a completed ballot when the VOTE button is pushed one time. This election when the summary ballot appears voters will need to press the VOTE button two times to record a completed ballot.

October 31 is the deadline for entries in the LWV Essay Contest. We will provide an update on entries in the December Voter and announce the winners in the Winter edition.



LWV Continues Lobby for Gun Safety

America faces an epidemic of gun-related violence that puts us in great need of stronger gun safety measures. Every day, 32 Americans are murdered with guns and 140 are treated for a gun assault in an emergency room. Death due to gunshot wounds is the second-leading cause of death for young people in the U.S., with a death rate that is nearly 12 times higher than that in other developed countries.

The League of Women Voters believes that it is past time for Congress and state legislatures to establish common sense solutions to prevent gun violence. Since 1990, local and state Leagues have held community meetings, testified before state legislatures and organized rallies in efforts to find common ground when it comes to gun safety.


In efforts to protect public health and safety, the League supports strong federal measures to limit the accessibility and regulate the ownership of guns, including banning assault weapons and limiting high capacity ammunition magazines, as well as funding much-needed research on gun violence in America. The League has also shown support for mandating waiting period for background checks, closing the gun show loophole and increasing penalties for straw purchases of guns.


Millions of Americans are at risk every day from senseless gun violence. The League is committed to working at the local, state and national levels to implement gun safety measures that will protect all Americans.
