


LWV to Tackle the Topic of Redistricting on Tuesday, Oct. 3





Please mark your calendars now for the Lexington League general meeting at **6:30 p.m. on Tuesday, Oct. 3**. The location will be the Farish Theater at the Lexington Public Library, 140 East Main Street.

The evening will focus on how to develop a redistricting process that allows voters to choose their representatives rather than legislators choosing their constituents. In other words, we will seek remedies for a situation where one political party or the other establishes an advantage by manipulating district boundaries. This practice is called gerrymandering and is evident in the difference between the two graphics on the left.

Susan Perkins Weston, League member who is writing a report for the state League's redistricting study, will present her findings. Two state representatives who have filed bills related to redistricting have also been invited.

The growth of lobbying in Kentucky has paralleled the mushrooming of lobbying at the federal level. To give an idea of the Kentucky picture, here is a link to an article covering 22 years of lobbying (up to 2015)—https://insiderlouisville.com/metro/what-22-years-of-lobbying-in-frankfort-looks-like/. I suspect that, on the state level as well as the federal, there is an inequality of interests advanced by professional lobbyists hired by large corporate groups compared to the volunteer efforts of non-profit, public-interest groups like the League.

If you have some interest, time and energy, please consider joining the Money in Politics study group to enable our League of Women Voters of Kentucky to make this an outstanding example of how study groups can work for other Leagues across America. While most of our work can be done individually with coordination by con-

Why We Volunteer

Members who worked at the LWV booth at the Woodland Art Fair on Aug. 19 and 20 found that most passers by were already registered. However, there were some who did want to register on paper or online and many others who needed to make address or party changes or who simply had unanswered questions.

While working at the LWV table, I had an interesting conversation with a college student who asked what we in the League were doing about the problems ex-felons face getting rights restored. The young man explained he had been convicted of a felony that he said resulted from a "stupid mistake." He had submitted an application for restoration of rights but is still waiting for the governor's signature. We talked about how he could advocate with the governor's office to get his request processed and the problem of regaining rights became personal for me. The issue now had another face.

This encounter inspires me to be more diligent in the work of addressing voter suppression. I hope we <u>all</u> become more determined to work in Frankfort for a constitutional amendment that will eliminate the unnecessary difficulties ex-felons face regaining their basic rights.

Former Diplomat to Address Christian Muslim Dialogue

On Saturday, Sept. 23 at 10:00 a.m. at Masjid Bilal (Mosque) Dr. Deborah Alexander, a former diplomatic envoy, will discuss her experiences in a talk entitled "A U.S. Diplomat's Decade in Afghanistan." She will focus on (1) her life as an American woman, often living with military troops, in the remote areas of Afghanistan; (2) her work with Afghans, both men and women, and (3) U.S. support of women and girls' assistance programs.

Her experiences ranged from being the first civilian embedded with U.S. Army Special Forces after 9/11 to supervising reconstruction projects like schools, hospitals radio stations and bridges to interning with Mother Teresa and the Missionaries of Charity. Dr. Alexander, now retired, splits her time between Washington, D.C., and Lexington.

The event, which will be followed by a pot luck meal for all who want to participate, will be held at the Mosque at 1545 Russell Cave Rd.

Mosque guideline for visitors:

- All women should dress modestly (no shorts or minis)
- Shoes should be removed before entering the meeting area

An Update on Charter Schools

As of August 24 the Kentucky State Board of Education had reviewed four proposed regulations: related to charter schools: 1.) student application, lottery and enrollment; 2.) evaluation of authorized performance; 3.) revocation and nonrenewal process for authorizers; and 4.) conversion charter school creation and operation. These will be discussed and voted on October 3-4 with all regulations approved by early 2018.

As the state moves forward we need to ask ourselves if there is anything charter schools can do that our public schools cannot. Fayette County already has a method of addressing specific student needs through the adoption of magnet school programs, many of which are already doing what charter schools propose to do. However, the issue of poverty remains a basic obstacle to student learning as was noted by Boone County superintendent Randy Poe, The national LWV education blog notes that charter schools, to this point, have not provided effective remedies to address the learning problems associated with poverty.

We will continue to monitor charter regulations as they are presented to the state board.
