Don't Miss League Day at the Capitol!



Mark Thursday, Feb. 7, on your calendar as the day you are invited to join with League friends exploring the Capitol, learning about bills and issues of interest and observe the legislature at work.

We will gather in Room 160 (part of the Secretary of State's office) at 9:15 a.m. (Not the Annex, our usual meeting place.) The Capitol will be crowded so plan to arrive early in order to clear security. Usually there are parking spaces in the garage which can easily be accessed from Rte 420. See Directions in the box below. Be sure to have your ID with you and wear your League button and comfortable shoes.

First, we will go through an overview of bills and what to expect from this session. At 10:30 a.m. you can choose committee meetings to attend or legislative offices to visit.

To actually talk with a legislator in such a busy week an appointment needs to be made ahead of time. Call 502-564-8100 and the operator will connect you with the office(s) you want. If you prefer, you can always write notes at home and deliver to their offices at this time.

DIRECTIONS FROM LEXINGTON:

Take either I-64 or US 60 toward Frankfort. Where they intersect, continue north on US 60 to the East-West Connector (Rte. 676).

Turn left and go to the first stoplight past the river. This will be Rte. 420. Turn right and continue to Capitol parking garage on your left.

Check out More Opportunities to Get Involved

Whether you are a long time member or a fresh new face in the group, there are plenty of opportunities to become more involved in the work of the League. Step up, meet new friends, add your perspective to one of the following:

- Voter Registration—To be successful, this outreach takes a lot of member participation. There are so many opportunities to have a visible presence in the community! And the first step is to participate in a one time training. To participate in the first training you must sign up on the website at https://linearchy.com/ newevents/2019/3/4voter-registration-training. The training is scheduled for 7:30 p.m. on Mon., March 4, at the Beaumont Library.
- Observer Corps—This is one of the easiest assignments, which asks individuals to monitor meetings of local government and agencies for issues that might be relevant to the League. Any interested member can choose a local entity—school board, library board, urban-county council—and check its schedule for meetings. These can be followed either in person on by viewing broadcast of meeting. A brief summary is then submitted to the LWV board. Release of LWV 2019 Felony Disenfranchisement Report



<u>lwvky.org.</u> This document contains new data, including

polling results for question to voters about support for automatic restoration of rights. It lays out findings and recommendations.

This document clearly identifies why Kentucky is on its way to being the only state that permanently disenfranchises persons with felony convictions. It also will be a guide for future League action. All members are asked to read the report and share the information with others. We must move Kentucky forward!

Major Points of HR1

It is easy to be overwhelmed by an omnibus bill like the first bill proposed by the U.S. Congress House of Representatives in the 116th session. Yet this bill contains so much that the League has worked years to support. It is important that we all understand at least the four key elements.

Measures to Expand Voter Registration—

These address complicated registration and deadlines that vary by state and county, wrongfully purged voters, recounting processes and audits.


Measures That Implement Fair Redistrict-

ing—Here are clear rules around state redistricting processes so that fair maps can be drawn.

Measures That Outlaw Voter Purging—This section would ensure that voters' rights will not be stripped away because politicians have illegally removed their names from the voter rolls.

Measures That Restore the VRA—Since the Supreme Court's decision in 2013 that rolled back key provisions of the Voting Rights Act the process has become more challenging, especially for women and communities of color. Restoring the VRA will cut back on the obstructive laws that have kept eligible voters from exercising their rights at the ballot box.
